The studies have shown that early thrombolysis (up to 2 hours) is effective in all groups of patients, and the delayed therapy (more than 6 hours) has demonstrated mixed results. The efficacy in metalyse was higher than that of actilyse and streptokinase. So, the determining factor of the re-perfusion is the start of thrombolysis.

At present, three types of logic are known: 1) objective ''logic of things'', independent of a person; 2) subjective (of a subject) ''logic of practice'' which reflects ''logic of things''; 3) ''logic of reasoning'' based on ''logic of practice'' also as a reflection of 'logic of things'. In our understanding of the matter, *logic of reasoning* is a system of rules and forms which are followed objectively and which contain elements of thought and relations. Without such rules and forms the relation between thoughts is not carried out, without thoughts it is impossible to reflect on relations and connections in reality.
